### *Summer Camp Enrollment Agreement (Terms & Conditions)*

1. The Summer Camp program fees are as follows:
  - a. REGISTRATION: Non-refundable registration fee of \$49.95 per family, due when entering the program
  - b. TUITION
    - i. \$125 per week (week = 3-5 days) Until May 1<sup>st</sup>.
    - ii. Regular price \$135 per week after May 1<sup>st</sup>. Early bird special ends
    - iii. \$30.00 per day (1-2 days – this option is only available if space permits)

We offer a family discount of 15% off regular tuition for each additional child.

We require a 20% nonrefundable deposit for each week that you sign up for. This is due at registration.

2. Parent/guardian agrees to pay the weekly tuition fee as set by World Class Taekwondo. All tuition fees must be by credit card on autopay to be charged on Saturday for the upcoming week. If payment is declined by card issuer, parent will be immediately informed. Payment issue must be resolved by Monday morning
3. Please plan carefully, as you are responsible for paying for weeks that you have reserved on the previous page. You will be charged for weeks reserved, whether your child attends or not. We have to limit the number of students enrolled each week, due to transportation limits and staffing.
4. If student is signed up for the full week (3 or more days) Parent/guardian agrees to pay full weekly tuition fee, even if that child is absent for one or more days during the calendar week (Monday through Friday).

Parent/guardian agrees to pick up student from Summer camp program by 6:30 pm.

MEMBERSHIP AGREEMENT/WAIVER OF LIABILITY

This agreement executed on the date shown at the bottom of this page by and between World Class TaeKwonDo hereinafter referred to as the School, and the buyer, who has caused his/her signature to be affixed hereto, hereafter referred to as the Enrollee or Buyer. The School agrees to provide instructions in Tae Kwon Do to the enrollee during the scheduled instruction hours of the School. Enrollee understands that it is his or her responsibility to attend instruction sessions. Enrollee understands that the entire course fee stated on the front is due and payable according to the terms of this agreement whether or not Enrollee chooses to attend instruction sessions provided by the School. In consideration for the School's premises to instruct and provide facilities, Enrollee agrees and promises to pay the course fees shown on the registration form. In the event of default in the payment of any installment of fee in accordance with the terms above, or a breach of any of the covenants herein contained to be performed by the Enrollee, the balance due under this agreement shall become immediately due and payable. Enrollee agrees to abide by the rules and regulations governing the conduct and operation of instruction sessions, students, and observers, in order to promote efficiency, and safety as prescribed by the School. Enrollee agrees to abide by all such rules and regulations as adopted or hereinafter amended. The hours of operations may be changed at the discretions of the School. The School reserves the right to revoke or terminate any membership. Enrollee warrants that he or she has not at any time suffered any blackout, seizure, convulsion, and fainting or dizzy spells and is not presently receiving treatment for any illness, disorder or injury, which would render it unsafe for the Enrollee to take part in Martial Arts. Enrollee agrees that all exercise and/or instruction are taken at student's own risk. The Enrollee understands the procedures and exercises involved in instruction and participation as explained to him/her by an assistant of the School. The Enrollee understands that there is a risk of personal injury involved in the course of instructions and with this knowledge agrees to indemnify and save harmless the School from all losses caused by accident or injury to the Enrollees, or to third persons, who may be with the Enrollee of the School, in the event that either the Enrollee or said third person is injured in any way during the performance and execution or exercise. The company owning the School and the agents and employees shall not be responsible for damaged, lost or stolen articles inside or outside the facility. The School reserves the right to amend or add to these rules and conditions and to adopt new rules as it may deem necessary. If an Enrollee desires to transfer his/her membership to another individual, a transfer fee will be assessed to cover our cost, which will not exceed \$150.00. Memberships obtained on a special are not transferable or freezable.

I, the Enrollee or the Member, irrevocably authorize the School, its successor and assigns, and those acting under its authority, to copy, use, publish, for art, advertising, trade, or any other lawful purpose whatsoever, photography, portraits, pictures or videotapes of me, in which I may be included in whole or in part.

In consideration of the training obtained, I agree that I will not, during continuance of this agreement, and for a period of 5 years following termination of my association with the School, engage in teaching Tae Kwon Do or offer similar training or instruction within a fifty (50) mile radius of any school operated by the School without express written consent.

Should the Buyer choose to pay for more than on month of this agreement in advance, be aware that you are paying for future services and may be risking loss of your money in the event this School and/or business location ceases to operate. This School is not required to provide any security, and there may not be other protections provided to you should you choose to pay in advance. The School does not give refunds to advance payments made for future services.

In order to cover the costs of registration, promotion certificates and new belts, a testing fee is charged at each examination. Being a member at the School you faithfully comply with all rules and regulations of the School and traditions of Tae Kwon Do. Instruction is not provided on national holidays, examination day, natural disaster days or on days of tournaments.

CONSUMER RIGHT OF CANCELLATION: You may cancel this agreement penalty free within 3 days of execution date of agreement, exclusive of holidays and weekends upon mailing or delivering written certified notice to the School. This agreement may be cancelled for reasons of death or substantial disability by providing death certificate or disability statement by certified physician. You may cancel this agreement if the center goes out of business and fails to provide facilities within 25 miles of, or moves its facilities more than 25 miles from the present facilities.

You understand further that strict observation by you of the rules and regulations relative to your training including the use of protective equipment required by the School will largely eliminate the possibility of accident or injury and that you waive any claim of damages against the School and/or principles of instruction in any case resulting from the activity. In order to comply with proper safety standards, equipment must be purchased through World Class TaeKwonDo.

I agree to waive any and all claims against persons affiliated with the World Class TaeKwonDo.

I give permission for my child to be transported and to receive any and all emergency health care attention needed should the need arise.

I give permission for my child to be picked up from their school and transported to World Class TaeKwonDo.
